A bill proposed by the New York City Chapter of HLAA to require the city's movie theaters to offer weekly open-captioned screening for every film, was overwhelmingly passed by the City Council in December. The groundbreaking bill culminates years of efforts by the deaf and hard of hearing communities to address problematic access to movies via the use of closed-caption devices as required under the Americans with Disabilities Act.

Special thanks to HLAA-NYC Chapter members Katherine Bouton, Ruth Bernstein, and Jerry Bergman. The successful effort in support of the bill's passage was led by Bergman and John Waldo, a disability rights attorney with profound hearing loss and a veteran advocate for cinema accessibility.

The bill is expected to be signed into law soon by Mayor Eric Adams and will take effect 120 days later.



When we work together to effect positive change under the umbrella of a respected organization like HLAA, we can, and will, make good things happen. Watch for opportunities to work towards legislation in Wisconsin. Your voice matters! Lend your voice to HLAA by becoming a member.

Two Chapter Subgroups; Each With it's Own Purpose

HLAA Fox Valley Chapter offers two sub support groups, Cochlear Implant Group and H.O.P.E. which stands for "Hearing Other People's Experiences". Both groups provide the opportunity to ask basic questions and to share personal experiences.

The CI group is primarily for adult CI recipients and potential CI candidates. We are not 'brand specific', and have implant recipients representing all three major manufacturers; Cochlear Americas, Med El and Advanced Bionics. They also come from a variety of hospitals that provide cochlear implantation

CI group members answer questions to help potential candidates with decision making, surgery (pro + con), and expected outcomes. Impromptu discussions that include problem solving with devices/equipment, new information released from manufactures, and coping strategies for improved communication are typical. Sharing our stories inspires hope as it gives help.

The H.O.P.E. support group provides an opportunity to learn the basics of living well with hearing loss. So often people who are diagnosed with hearing loss are confused about what to do, what to buy, and what to expect. We educate by sharing information. We focus on providing peer support while encouraging everyone to reach out to others. H.O.P.E. encourages spouses, partners, family members and friends to participate. H.O.P.E. provides a free-floating discussion that will benefit people who are just beginning or who might be stuck in their hearing loss journey. People who have had hearing loss for years who want to reach out to help others are also involved in H.O.P.E.

We talk about hearing tests, degree of hearing loss, assistive technology and how to access it, among many other things that people with hearing loss don't often get from the professionals. H.O.P.E provides mutual support as we share our experiences, both good and not so good. New people are always amazed to learn they are not alone with these experiences. We know that hearing loss affects the whole family, whether you have the "listening challenges" or someone close to you does. We are NOT experts, but we have experience living with hearing loss ourselves. We believe that helping others is central to living WELL with hearing loss. We know because others helped us!

Until the end of the pandemic, CI and H.O.P.E. will alternate every other month via ZOOM. When the chapter can meet in person again, H.O.P.E. will return to it's original schedule of meeting before the monthly chapter meeting, with ample social time between the two. We subgroup facilitators will work to keep the meetings to a reasonable length. At that time, the CI group will likely continue to meet every other month via ZOOM. Our subgroups will meet on the 3rd Tuesdays, except when that Tuesday falls during the same week as the chapter meeting. In that case, they will shift to the 4th Tuesday.

Text to 911 Now Available in Some Wisconsin Counties

Text to 911 is now available in Outagamie County. Google 'text to 911' to see if it's available in your county. It's a great way for those needing help to send a text to a dispatcher. When you send a text, it rings like a 911 call.



When texting in an emergency, Enter 911 in the To field. (no dashes). Give your exact location and type of emergency. Keep it brief, be prepared to answer questions and follow instructions. Do not use emoji's, and don't abbreviate. Text to 911 is for texting only, you cannot send photos or videos but that will be possible in the future.

My neighbor, Lt. Meghan Cash, explained that it has been very successful in situations of domestic violence and other violent crimes. She said, "The Text 911 capability available at Outagamie County is an excellent step in improving accessibility for members of our community to contact emergency services. The use of this tool already has been positive, and we look forward to seeing the additional ways it will impact the level of service we can provide to our community."

I believe this could be lifesaving for some of the deaf and hard of hearing community, also for those with speech difficulties. There are many situations where '911' can save lives. It is another form of 'access' for individuals with disabilities. Think about it: There could be a car crash, a fire, or if you are injured, its good to know it is now a little easier to get help! I understand that Text to 911 was used when two kids texted from the backseat of the car and reported their Dad was driving drunk. Another example was a deaf woman texted 911 because she accidentally locked her kids in the car. 2022 Margaret Ferris Scholarship

Eligibility: Graduating high school seniors from a public or parochial high school in Calumet, Outagamie or Winnebago counties who are planning to pursue post-secondary education at an accredited college, university or technical college. Applicants must be hard of hearing students with significant hearing loss who use technology to participate in the hearing world. One non renewable \$2000 scholarship will be awarded. NOTE: HLAAFV has contributed funds to provide a second scholarship in the amount of \$1000 to the Ferris Scholarship, in the event there is more than one applicant who applies and meets the criteria for the Ferris award in 2022.
